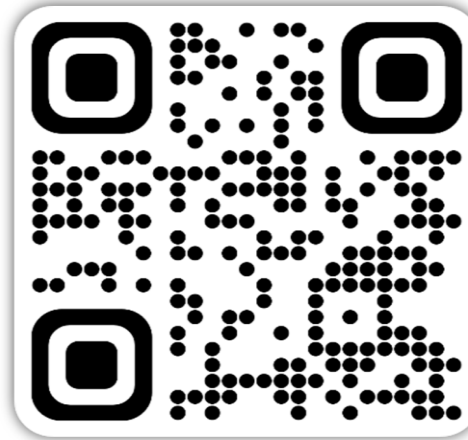

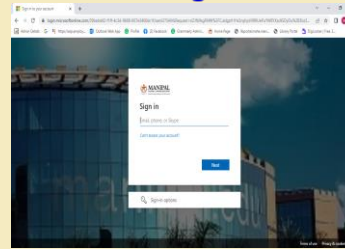

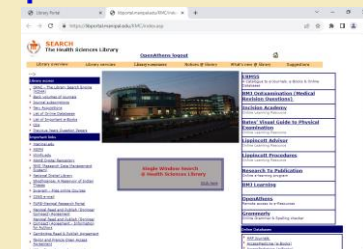
Step I: Scan the QR Code
